ACI 301 Section 1.6.4.1.c states, "The testing agency will report test and inspection results that pertain to the work to the Architect/Engineer, Contractor, and concrete supplier within 7 days after tests and inspections are performed."

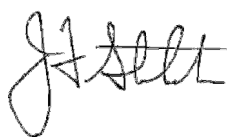
ASTM C94 Section 6.7 states, "The purchaser shall ensure that the manufacturer is provided copies of all reports of tests performed on concrete samples taken to determine compliance with specification requirements. Reports shall be provided on a timely basis."

This requirement allows us to track trends on your project, our raw materials, and address any potential problems before they become large scale. Also, these reports provide essential information required for submittals of historical data on future project submittals.
