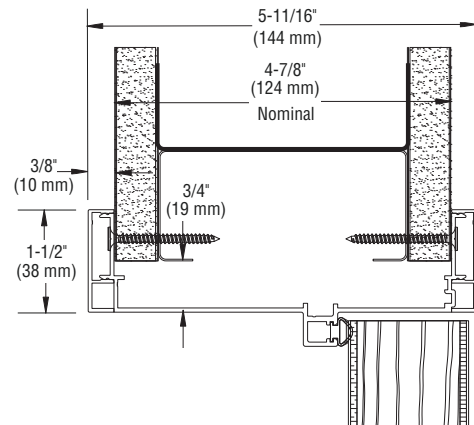

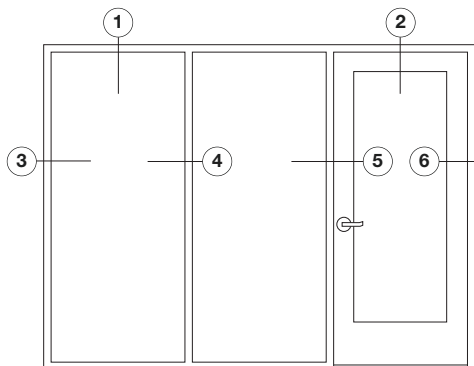

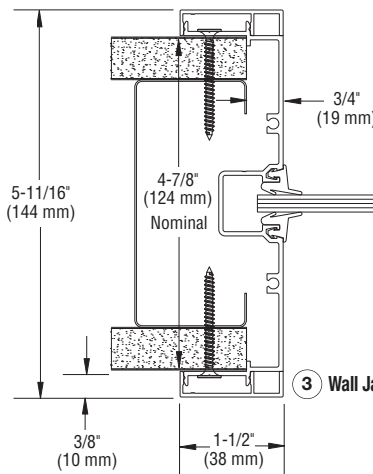
① Fixed Glazing Header



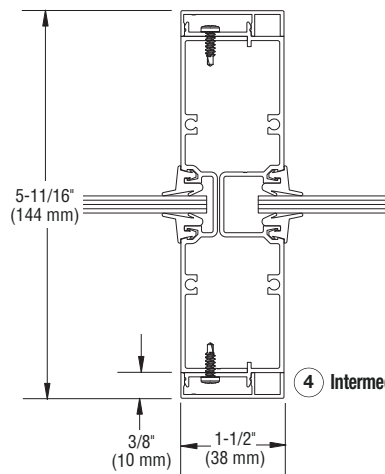
② Door Header



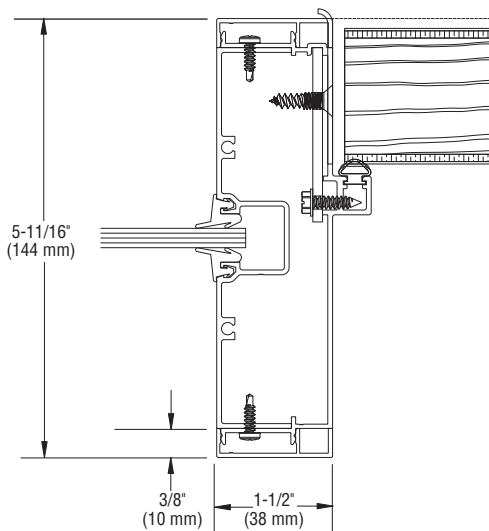
Typical Elevation



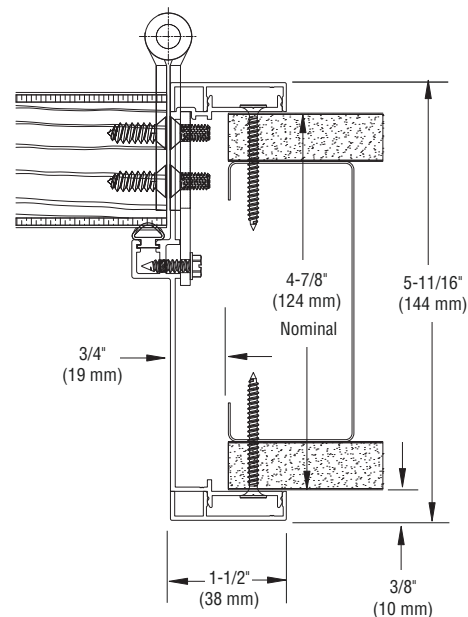
③ Wall Jamb

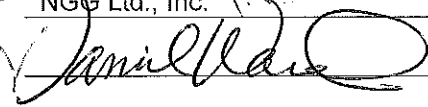
